

## FAQs on Exhibition Stalls

1. Are there specific size requirements for posters (e.g., A1, A2, A3)?

Ans. 50" LED TV, JPG format, Pixel Size 1080 x 1920 [16:9]

2. What are the dimensions of the walls or display panels in the stall?

Ans. Octanorm Panel Size 37"W x 94"H, 3ft W x 8ft H for each panel  
[2 mtrs 2 Panels in ft 6.5 ftW and H 8 ft]  
[3 mtrs 3 Panels in ft 10 ftW and H 8 ft]  
[4 mtrs 4 Panels in ft 13 ftW and H 8 ft]  
any wood Fabrication reduce 2" overall

3. Are there pre-allocated spaces for sticking or mounting posters?

Ans. Back area of Auditorium they can use, any customize Stall painting outside only, they have to give Rs. 1000/- maintain charge each stall

4. Are we allowed to stick posters directly on walls/panels?

Ans. Not allowed for pasting/sticking directly, We can do with form Board with 2side gum tape

5. What adhesives or mounting methods are recommended or restricted (e.g., tape, Velcro, pins)?

Ans. Wooden Frame/ Iron Frame Only allowed, sticking they can use 2side gum tape, 3M Tape

6. Do you recommend any specific type of material for the posters (e.g., foam board, flex)?

Ans. Fabric Banner and form Board, play sheet

7. Do the posters need prior approval from the organizers?

Ans. Yes

8. Are there height restrictions for posters or banners?

Ans. Yes, 8 ft H [Only Stall No. 1, 2, 3 they can go with upto 9.5 ft H]

9. Are digital posters or screens provided?

Ans. Extra Cost only

10. Can we use the back or sides of the stall for additional displays?

Ans. if organizer permitted only, [corner stalls no. 1, 4, 7, 10, 11, 12, 19, 20, 27, 28, 29, 30, 38, 39]

11. If extra power they have to pay

Ans. 0.5 kva power for each stall provide by organizer [Extra charged as per stalls requirements]
